- Child product safety
- Impaired driving
- Child maltreatment
- Sexual assault/intimate partner abuse
- Suicide/self-inflicted injury
- Traumatic brain injury

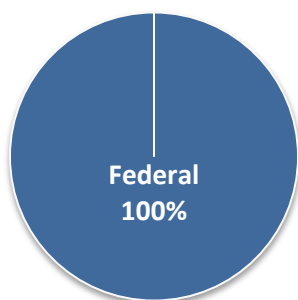
PREVENTION IN ACTION IN ILLINOIS

- During the 2015-2016 school year, provided evidence-based/ evidence-informed educational sessions for 418,192 youth, in grades K through 12, to change beliefs and attitudes about sexual violence.
- Between 2012-2016, over 1,950,000 persons were reached through a variety of suicide prevention trainings, partnerships, awareness efforts, screenings and referrals offered throughout the state.
- Trained over 2,700 individuals, including community members, hospital staff, health care providers, child care providers, police officers and first responders on sudden infant death syndrome and sleep-related infant death risk reduction and infant safe sleep in 2016.

PROGRAM FUNDING

State public health IVP programs piece together and manage funding from multiple sources for prevention efforts. In Illinois, the IVP program relies solely on funding from federal funding sources.
