#### SPEAKER BIOGRAPHIES

#### Elizabeth Alleman, MPH

Elizabeth Alleman, MPH, is an epidemiologist with the DuPage County Health Department located in Wheaton, Illinois. She earned her Master of Public Health in Epidemiology from Saint Louis University. Her primary role as epidemiologist encompasses the surveillance and prevention of infectious, chronic, behavioral, and environmental causes of morbidity and mortality. More recently, the DuPage County Health Department is partnering with a long-term care facility, the DuPage Convalescent Center, to support implementation of an antimicrobial stewardship program, aimed to improve antibiotic use in the facility through education, awareness, and surveillance.

#### Scott Bergman, PharmD, BCPS (AQ ID)

Scott Bergman is an Associate Professor at the Southern Illinois University Edwardsville (SIUE) School of Pharmacy and an infectious diseases clinical pharmacy specialist. Dr. Bergman holds a joint appointment with the Division of Infectious Diseases at the SIU School of Medicine here in Springfield where he contributes to inter-professional teaching rounds on patients at both hospitals as well as outpatient clinics. He is program director and preceptor for the post-graduate year 2 infectious diseases pharmacy residency at HSHS St. John's Hospital and also a preceptor to PGY-1 pharmacy residents at Memorial Medical Center. He was awarded the 2012 Excellence in Innovation Award from the Illinois Pharmacists Association and 2013 New Practitioner Leadership Award from the Illinois Council of Health-System Pharmacists. Dr. Bergman joined SIUE in 2006 from West Virginia University Hospitals and School of Pharmacy where he completed residencies in pharmacy practice and infectious diseases pharmacotherapy. He graduated from the College of Pharmacy at South Dakota State University with his Doctorate in Pharmacy and B.S. in Pharmaceutical Sciences. His areas of interest include the appropriate use of antimicrobials, immunizations, rapid-diagnostic testing and treatment of medical device-related biofilm infections.

# Sandy Cabrera, RN/ADON

Originally from Guatemala, Sandy moved to Chicago at 17 years old and started working with special needs children where she found her passion for nursing since she worked with children. She obtained her nursing degree in 2008 and has since worked in a variety of healthcare settings, including home health, acute care, and long term care. Sandy is continuing her education to become a nurse practitioner in order to provide excellent care and change lives one person at a time.

# Alan Gross, PharmD, BCPS

Alan Gross is a Clinical Assistant Professor at the University of Illinois at College of Pharmacy and the Antimicrobial Stewardship Pharmacist at University of Illinois Hospital. Dr. Gross received his pharmacy degree from Purdue University and subsequently completed a PGY1 pharmacy practice residency at Henry Ford Hospital and a PGY2 infectious diseases residency at Midwestern University Chicago College of Pharmacy. He currently serves as the chair of the Antimicrobial Stewardship Committee for the Society of Infectious Diseases Pharmacists. His primary research interests include the epidemiology and treatment of multidrug-resistant organisms and the treatment of respiratory tract infections.

#### Gail S. Itokazu, Pharm.D.

Gail S. Itokazu, Pharm.D, is a Clinical Associate Professor at the University of Illinois at Chicago College of Pharmacy. She received her pharmacy degree from the Philadelphia College of Pharmacy & Science (The University of the Sciences in Philadelphia), subsequently completing a Fellowship in Infectious Diseases/Surgery at the College of Pharmacy, University of Illinois at Chicago. Since 1990, Dr. Itokazu has served as a Clinical Pharmacist in Infectious Diseases, first at Michael Reese Hospital, Chicago, IL (1990-1994), and currently at John H. Stroger Jr. Hospital of Cook County, Chicago, IL (1994-present). Her areas of interest include the development and implementation of programs to optimize antimicrobial use in hospitalized patients and the care of HIV-infected persons.

#### Tamara Link, DNP, FNP-BC

Dr. Tamara Link is a board-certified Family Nurse Practitioner. She completed her DNP at Duke University School of Nursing in 2016 and her MSN-FNP at the Uniformed Services University of the Health Sciences in Bethesda, MN in 1998. Her recent doctoral project was entitled "Reducing Inappropriate Antibiotic Prescribing for Adults with Acute Bronchitis in an Urgent Care Setting." She has worked as a FNP at FastMed Urgent Care in Holly Springs, NC since 2011. Prior to that, Dr. Link worked in

various family practice settings for 13 years. She is a decorated military veteran and retired at the rank of Lieutenant Colonel after a 20-year career in the United States Air Force. Her military nursing experience as an FNP and a RN include: family practice, fast track clinics, inpatient obstetrical and medical/surgical nursing, and aeromedical evacuation nursing. She is a member various professional organizations including the Urgent Care Association of America and the American Academy of Emergency Nurse Practitioners.

#### Dheeraj Mahajan, MD, CMD

Dr. Dheeraj Mahajan is President and CEO of the Chicago Internal Medicine Practice and Research (CIMPAR, SC) and a Clinical Associate Professor of Medicine at University of Illinois at Chicago. He is a Fellow in Geriatric Medicine and certified in Internal Medicine and Geriatric Medicine. In 2014, he became a Fellow of the Institute of Medicine, Chicago.

Additionally, Dr. Mahajan is a certified medical director and is certified in infection control and epidemiology. He specializes in cross-continuum provider alignment and is a nationally recognized speaker on post-acute care and quality improvement. Dr. Mahajan started as a solo practitioner in 2006 and today his group practice has grown to eight physicians, three APNs, one PA-C and 22 full time employees. He currently is the medical director at two CMS-rated five star skilled nursing facilities. At one of these facilities, he has implemented a transitional care unit (TCU) using evidenced based protocols, peer review best practices, strict admission order sets and protocols resulting in dramatically reducing hospital readmission rates, improved outcomes, and patient and family satisfaction.

### Daniella Meeker, PhD

Daniella Meeker is an Information Scientist at the RAND Corporation and an Assistant Professor in the Department of Preventive Medicine and Department of Pediatrics at the University Of Southern California Keck School Of Medicine. She is the Informatics Program Director for the Southern California Clinical Transnational Sciences Institute. Her research focuses on the intersection of data science and implementation science, including applications of Behavioral Economics to improve data-driven quality improvement tools.

#### Phillippe Morency-Potvin, MD

Philippe Morency-Potvin is a Canadian board-certified clinical microbiologist and infectious disease specialist. He completed his training at Universite de Montreal in 2014. He has been in Chicago for 18 months to complete a post-doctoral training in antimicrobial stewardship at Cook County Health and Hospital Systems and Rush University. Upon completion, he will return to the Centre Hospitalier de l'Universite de Montreal where he will be in charge of managing the antimicrobial stewardship program.

#### Phyliss Royster, RN, PHD, LNHA

Phyliss M. Royster has 27 years of experience in Long-Term Care. She is the Director of Nursing at DuPage Convalescent Center in Wheaton, Illinois, a 368-bed skilled sub-acute rehab nursing center with a Special Care Alzheimer's secured unit. Ms. Royster has nursing experience in the following areas: Operating Room, Medical-Surgical, Ambulatory Care, Women's Health, Infection Control, and Long-Term Care. Phyliss has worked as The Joint Commission Coordinator at Kansas State University in Manhattan, Kansas, Applewood Nursing and Rehabilitation Center in Matteson Illinois, Ridgeland Nursing and Rehab Center in Palos Heights, Illinois, and DuPage County Convalescent Center in Wheaton, Illinois.

She began her work at IDPH in October 2011 as the Project Director for the Illinois Antimicrobial Stewardship Collaborative and co-leader of the Illinois Campaign to Eliminate *Clostridium difficile* (ICE

*C. diff*). Erica earned a Master of Public Health and Master of Science in Nursing from the University of Illinois at Chicago and has been inducted into Delta Omega Honorary Society in Public Health and Sigma Theta Tau International Honor Society of Nursing. In addition to maintaining active inpatient and ambulatory patient care and teaching roles, Dr. Schwartz has chaired the Cook County Hospital Anti-Infective Committee and supervised its antimicrobial stewardship efforts since 1994. He became chair of the hospital's pharmacy and therapeutics committee in 2007. Dr. Schwartz and colleagues have collaborated on research with the Centers for Disease Control and Prevention since 1999, focusing on the design and implementation of interventions to improve antimicrobial use and refine antimicrobial measurement in hospitals.
